The consent form must be returned to us 4 weeks prior to the start of course or returned to your school if you are coming as part of a group.

Please complete all sections and give a copy to your son/daughter to travel with.

The information you provide us will be dealt with in the strictest confidence and only shared with the required persons to deliver a service such as healthcare and welfare professionals or for legal reasons. For any paper copies we will hold this information below for a period of 2 years and then securely destroy this information. In providing the information requested below, you should note that LanguageUK promotes equality of opportunity and will take action to ensure that no individual suffers discrimination, directly or indirectly, on the grounds of gender, disability, colour, race, religious beliefs, sexual orientation, age, nationality, ethnic or national origin.

Travel

I understand and agree that:

The school does not accept responsibility for students under 18 who make their own travel arrangements from the airport or other arrival point until they arrive in Canterbury.)

- my son/daughter can travel unaccompanied between the school and his/her accommodation.
- my son/daughter will seek permission for any travel outside of Canterbury during their stay.
 I will need to give additional and specific consent for any overnight stays.

Attendance

I understand and agree that:

- my son/daughter is expected to attend all scheduled classes and activities. If I wish my son/daughter to be absent at any time, I must contact the school.
- he/she understands that he/she must follow the school's 'attendance policy'.

Curfew time

I understand and agree that:

- my son/daughter must be home by their curfew time (please see below) on any evening unless accompanied by a responsible adult approved by the school.
- CURFEW TIME for students under 18 years old on General English course: 10.00pm
- CURFEW TIME for students on the Summer Course and groups are not allowed out in the evening unless organised with LanguageUK and their leaders.

Unsupervised times

I understand and agree that:

- my son/daughter can have free time for shopping on trips.
- my son/daughter can have unsupervised free time in Canterbury during the time between the end of classes/activities and the time of the evening meal at their accommodation.
- my son/daughter can have unsupervised free time in the evenings and weekends.

Students aged 16/17 who are enrolled on adult courses

I understand and agree that:

- my son/daughter will come into regular contact with other students over the age of 18, in class and during the leisure programme.
- there are certain British laws (e.g., related to drinking alcohol) that apply to people aged under 18. Therefore, there may be some leisure activities which my son/daughter cannot take part in because of their age.

- I understand and agree that:
- it is illegal to buy alcohol under the age of 18 and illegal to buy cigarettes under the age of 18 or to smoke in public under the age of 16, and that the school will enforce these laws. If necessary, the school may search students' belongings and confiscate illegal or other items deemed to be inappropriate.
- we (the parents/guardians) are financially responsible for any damage that our son/daughter causes during his/her stay in the UK.
- if the school believes that the safety of my son/daughter is compromised, LanguageUK /homestay provider may impose further restrictions or rules as required.
- it is important to discuss staying safe online with our son/daughter and we have explained that he/she should not share personal information with strangers on the internet.
- my son/daughter must have adequate travel and medical insurance and will ensure they have this before they travel.
- my son/daughter understands that he/she must follow the school and homestay rules.
- my son/daughter must follow the school's policy on unreasonable behaviour:

- In the first instance, our staff will speak to the student explaining why the behaviour is unreasonable. If necessary, the student will then receive an official warning in writing with a copy sent to the parents.
- If unreasonable behaviour continues the student may be sent home immediately without a refund. The parents will be asked to pay for the return flight.

Terms & Conditions Please read carefully:

- Students will be placed 2,3 or 4 per homestay accommodation depending on the size of the house. If you are happy for your child to share a room with a friend or another student please sign above.
- Your son/daughter will follow the homestay host rules and requirements. Any damages committed by a student must be paid for by that student in full.
- We work very closely with the hosts, and we consider all the students' comments about them. We only
 move students if we feel the circumstances are correct and in an emergency. Students or leaders cannot
 decide for themselves that they want to be re housed before consulting with the accommodation officer. In
 both Canterbury and Faversham, we have designated welfare officers who oversee any accommodation
 moving and any welfare issues.
- Under no circumstances, without the host's consent, must a student take photos inside the house and use this photo on social media including Facebook, WhatsApp, Snapchat, Instagram, Twitter, and any other application. This is a serious invasion of privacy.
- LanguageUK are not liable for any videos, photos that are downloaded onto social media that causes distress or any legal action. The students who take the videos are responsible and liable Any students who are caught invading privacy will be expelled from the course.
- We understand the school reserves the right to terminate the course of any student who persistently breaks the rules seriously misconducts himself/herself at the school or in the homestay. In such cases there will be no refund for fees, and we will be responsible for our child's return and all costs. Misconduct may include possession/consumption of illegal drugs/alcohol, intentional damage of the school or homestay property, repeated disturbance in class and at the homestay, repeated breaking of the rules, criminal activity, and bullying.
- All students must attend all classes. LanguageUK has a strict attendance Policy. Students can be absent when they are not well and in such case the student must inform their group leader who will then inform the school and the welfare department straight away and a doctor's appointment can be booked if needed.
- Failure to sign and return this form back to the school, agent then LanguageUK when asked to do so may result in problems with your booking.
- Please note there will be no movement of homestay and classes once your child has been allocated a home and class at these present times.
- I am fully and personable responsible for my own safety and actions while and during my participation with LanguageUK on a course and I recognise that I may be at risk of contracting COVID-19.
- With full knowledge of the risks involved, I hereby release waive, discharge to LanguageUK its board of directors, employees and representatives and assign from any and all liabilities claims, demands, actions, and causes of actions whatsoever directly or indirectly arising out of a related to any loss or damage injury or death that may be sustained by me related to, COVID-19 while participating in any activity while in, or around the school or homestay provider that may lead to unintentionally exposure or harm due to COVID-19.
- I agree to indemnify, defend, and hold harmless LanguageUK from any costs, expenses, damages, lawsuits and or liabilities or claims due to injury loss or death related to COVID-19.
